**The Clinical Document Architecture (CDA<sup>®</sup>) is HL7's primary standard for representing structured clinical documentation on patients for the purposes of health information exchange.**

**The CDA certification exam tests proficiency in the overall attributes of the CDA document. To pass, knowledge of the CDA specification and implementation guides must be demonstrated, including the ability to apply this knowledge in real-world implementation efforts.**

**HL7 Version 2 (V2) is the most widely implemented healthcare standard in the world: 95% of US healthcare organizations are users and more than 35 countries have V2 implementations. This is especially true in the exchange of orders, results, admission/discharge/transfer (ADT) and public health communication.**
